NOTICE OF INTENDED PROSECUTION

In accordance with Section 1 of the Road Traffic Offenders Act, 1988, I give you notice that it is intended to take proceedings against the driver of motor vehicle T949PBL.

For the alleged offence of EXCEEDING A 30 MPH SPEED RESTRICTION

At 17:22 hours on 26/06/2005
at HIGHLANDS ROAD, FAREHAM, HAMPSHIRE (FIXED CAMERA).
Contrary to: 81 (1) RTRA 1984

Recorded speed: 42

You have been identified as being the owner, keeper, hirer or driver of the vehicle at the time of the alleged offence, or a person who has information that may lead to the identification of the driver. You are therefore required to provide the full name and address identifying the actual driver or give any information in your power which will lead to the driver's identification.

THE ALLEGATION IS SUPPORTED BY VIDEO &/OR PHOTOGRAPHIC EVIDENCE.

UNDER SECTION 172 OF THE ROAD TRAFFIC ACT, 1988 YOU ARE REQUIRED TO SUPPLY THE INFORMATION WITHIN 28 DAYS OF SERVICE OF THIS NOTICE. THE PENALTY FOR FAILURE TO SUPPLY INFORMATION IS SIMILAR TO THAT FOR THE ALLEGED OFFENCE - A FINE PLUS A DRIVING LICENCE ENDORSEMENT.

EXPLANATORY NOTES

WHEN COMPLETING THE RESPONSE FORM PLEASE PRINT IN BLOCK CAPITALS USING ONE CHARACTER PER WHITE SQUARE

THE RESPONSE - must be completed, signed and returned only by the person or a company representative, to whom it is addressed.

As the recipient of the notice, you are required under Section 172 of the Road Traffic Act, 1988, to provide the requested information by the completion of the response section which must be signed. Failure to do so within the time limit specified on the attached document will render you liable for prosecution. The maximum penalty for the offence is a fine of £1000 and endorsement of a driving licence.

FALSEHOOD OR PREVARICATION COULD LEAD TO A CRIMINAL CONVICTION

ADVICE AND GUIDANCE FOR COMPLETION OF THE FORM:

Completion by a private owner.

If you are a private individual and have identified yourself as the driver you must complete Part 1 as well as the header section. Please sign and date the form where indicated. An unsigned form will not be accepted.

If you wish to nominate another person as the driver, do not give them the form to complete. Complete the header section and Part 2 providing their details. We will write to them in due course. Please supply as much detail as possible.

Completion by a Company.

It is the responsibility of the Company Director / Secretary to complete this document, not the driver concerned.

Do not give this form to the nominated driver, but complete the header section and Part 2 supplying the drivers' details. We will then correspond with that driver. You should supply the residential address of the individual and not a c/o address. Please check that your address records are correct before completion of the document.

Owner's liability.

It is a legal responsibility to supply the information required. Failure to supply this information is an offence that will result in court proceedings. Liability cannot be evaded.

Driving Licence details.

It is essential that you supply the correct driver number. The driver number commences with the first five letters of your surname. If you do not hold a DVLA, Swansea issued licence please indicate this on the response document. If you have lost or mislaid your licence you must apply for a replacement immediately. DVLA only issue Photocard Licences. If the replacement is the first application for a Photocard licence you must obtain the correct documents from a Post Office. If the address shown on your current licence is incorrect, please do not apply to the DVLA for a replacement now, but it can be forwarded to the DVLA at the conclusion of the case.

Video &/or Photographic evidence.

This will not be supplied as a matter of routine. It will be used in any subsequent court hearing.

We have evidence that you were the driver of motor vehicle T949PBL at the time of the alleged offence of:
EXCEEDING A 30 MPH SPEED RESTRICTION

At 17:22 hours on 26/06/2005
at HIGHLANDS ROAD, FAREHAM, HAMPSHIRE (FIXED CAMERA).
Contrary to: 81 (1) RTA 1984

It is possible that this case can be dealt with by a fixed penalty payment of £60 and a 3 penalty point endorsement on your driving licence, without the necessity for court proceedings. The Road Traffic Offenders Act, 1988 provides that where there is sufficient evidence to justify the commencement of proceedings for certain offences, a conditional offer of a fixed penalty resolution may be made instead of prosecution. If you can fulfil the conditions of such an offer which are printed overleaf, you are discharged from liability to prosecution and no court proceedings will be instituted against you. If however you do not meet these conditions you will remain liable for the offence and court prosecution procedures will be commenced against you. If you wish to contest this allegation in court you may do so.

IF YOU WISH TO BE CONSIDERED FOR A FIXED PENALTY PLEASE READ THE INSTRUCTIONS OVERLEAF AND FOLLOW THEM CAREFULLY

YOU HAVE 28 DAYS FROM THE DATE OF THIS NOTICE TO TAKE UP THE CONDITIONAL OFFER.
No proceedings will be commenced against you during this period, **but failure to respond to this notice or comply with the conditions overleaf will result in prosecution.**

To take advantage of fixed penalty procedures:

1. You must not have more than eight penalty point endorsements of your licence.
2. You must pay the fixed penalty amount specified overleaf and send your licence to the fixed penalty clerk at the address shown on the payment section of this form, within the time limit indicated.

Note:

Drivers in possession of a Photocard Driving Licence must send the photocard **and** the counterpart section of the licence.

Only holders of driving licences issued by the DVLA, Swansea may enter the fixed penalty scheme.

HOW TO PAY THE FIXED PENALTY

1. Fill in the payment form on the other side of this notice.
2. Send

(b) YOUR DRIVING LICENCE

to the fixed penalty office shown on the payment section of the form.

The fixed penalty clerk will inspect your licence to be satisfied that it is valid and to ensure that the condition regarding the number of penalty points has been met.

If you meet the requirements, your licence will be endorsed and your payment accepted. Your liability for court proceedings will then be discharged.

You must pay the full amount within the stated time.

You must pay the full amount in one payment. Payment by instalments will not be accepted.
