SOLICITORS' (NON-CONTENTIOUS BUSINESS) REMUNERATION ORDER 1994

- 1. If you are not satisfied with the amount of our fee you have the right to ask us to obtain a remuneration certificate from the Law Society.
- 2. The Certificate will either say that our fee is fair and reasonable, or it will substitute a lower fee.
- 3. If you wish us to obtain a certificate you must ask us to do so within a month of receiving this notice.
- 4. We may charge interest on unpaid bills and we will do so at the rate payable on judgment debts, from one month after delivery or our bill.
- 5. (i) If you ask us to obtain a remuneration certificate, then unless we already hold the money to cover these, you must first pay (a) half of our fee shown in the bill, and (b) all the VAT shown in the bill, and (c) all the expenses we have incurred shown in the bill sometimes called "paid disbursements".

(ii) However, you may ask the Law Society (at 8 Dormer Place, Royal Learnington Spa, Warwickshire, CV32 5AE) to waive these requirements so that you do not have to pay anything for the time being. You would have to show that exceptional circumstances apply in your case.

- 6. Your rights are set out more fully in the Solicitors (Non-Contentious Business) Remuneration Order 1994
- 7. Without prejudice to your right to a Law Society certificate, you may be entitled to have our charges reviewed by the court (This is called "taxation"). The procedure is different from the remuneration certificate procedure and it is set out in ss.70, 71 and 72 of the Solicitors Act 1974.
- 8. Different criteria apply to contentious bills in respect of which it is not possible to apply for a Remuneration Certificate but only for taxation of the bill.

FACTORS TO BE TAKEN INTO ACCOUNT WHEN ASSESSING SOLICITORS' FEES

- 1. The complexity of the matter or the difficulty or novelty of the question raised
- 2. The skill, labour, specialised knowledge and responsibility involved
- 3. The time spent on the business
- 4. The number and importance of the documents prepared or perused, without regard to length
- 5. The place where and the circumstances in which the business or any part thereof is transacted
- 6. The amount or value of any money or property involved
- 7. Whether any land involved is registered land within the meaning of the Land Registration Act 1925; and
- 8. The importance of the matter to the client
- 9. The approval (express or implied) of the entitled person or the express approval of the testator to (i) the solicitor undertaking all or any part of the work giving rise to the costs; or (ii) the amount of the costs
