

# **THIS IS THE LAST WILL** of me **FRANK O'GORMAN**

**of 6 Eddeys Lane Headley Down Hampshire GU35 8HU**

1. I REVOKE all my former Wills and testamentary dispositions
2. I APPOINT MONICA EILEEN CROUCHER of 23 The Ridgeway Alton Hampshire GU34 2RZ or if she is unable or unwilling to act then my Sister PATRICIA ANN CAMMOCK of 64 Alma Street Taunton Somerset TA1 3AL to be the Executors and Trustees hereof and I DECLARE that the expression "my Trustees" shall mean the person or persons who shall prove my Will or the Trustee or Trustees for the time being hereof
3. I GIVE all my property whatever and wherever situate unto my Trustees upon trust to sell call in and convert the same into money with power to postpone the sale calling in and conversion thereof so long as they shall in their absolute discretion think fit without being liable for loss
4. MY TRUSTEES shall stand possessed of the net proceeds of the sale and conversion and my ready money after payment thereof of my funeral and testamentary expenses debts legacies and all Inheritance Tax payable on my death in respect of my estate whether real or personal (hereinafter called "my residuary estate") for the said MONICA EILEEN CROUCHER absolutely or if she has predeceased me then for my said Sister PATRICIA ANN CAMMOCK absolutely
5. I DECLARE that my executors shall have power to take all such actions and to execute all such documents as may be necessary to ensure that the title to all land in my estate is fully and effectively transferred to the person or persons entitled to it and that all costs of registration [including land registry fees] shall be payable by my executors out of my residuary estate as if they were a proper testamentary expense

6. EVERY person who would otherwise benefit under this my Will but who does not survive me by the period of one calendar month shall be treated for all the purposes hereof (except those of S.19 Administration of Justice Act 1982) and for the purposes of the devolution of my estate as having predeceased me and my estate and the intermediate income thereof shall accordingly devolve to the intent that no such person shall be entitled to any intermediate income from my estate or any part of it if he dies within the said period nor acquire in any part thereof a vested interest (whether or not subject to defeasance) before the end of the said period

7. THE Standard Provisions of the Society of Trust and Estate Practitioners (1st Edition) shall apply to and be incorporated in this my Will; Section 11 of Trusts of Land and Appointment of Trustees Act 1996 shall not apply hereto; Section 19 of Trusts of Land and Appointment of Trustees Act 1996 shall not apply to any trust arising under this Will
