The Which? online fuel calculator (www.which.co.uk/ fuelcalculator) is an excellent aid to establishing accurate fuel consumption and cost.

I've run a spreadsheet on this basis for some years, and try not to be fooled by the 'fuel consumption computer' on modern vehicles. My VW Golf diesel, for example, is dramatically inaccurate, telling me that I achieve between 50 and 55mpg, while I actually get 42 to 46mpg.

TV screen distortion

I bought a new Panasonic TV and DVD recorder about nine months ago, but the TV regularly suffers from screen distortion – mainly square shapes appearing and the screen freezing. Virgin Media has replaced several set-top boxes, but the problem persists. What should I do? LEN CLARK, HERTFORDSHIRE

You need to identify where the problem lies. See if the TV works when it's hooked up to an analogue aerial. If it does, it's a problem with Virgin Media, the DVD recorder or the connections.

It probably won't be the set-top box, as Virgin Media has replaced several, but it could be the cables, so check these too. Remove the DVD recorder, and if the problem disappears you know it's faulty. To see if it's the connections, try using alternative Scart inputs on the

DVD recorder and TV, and try new leads. If it's a problem with the TV or DVD recorder, get the retailer to fix or replace it – you're entitled to this under the Sale of Goods Act 1979.

Sales calls

I'm on the Telephone Preference Service (TPS) register, which usually keeps the amount of cold calling down, but I've recently

received three evening sales and marketing calls. Isn't this illegal? JOHN STOKES, SOUTHAMPTON

It's a legal requirement for UK organisations to not make unsolicited sales calls to numbers registered with the TPS, unless they have your consent to do so.

You may have inadvertently consented to be called by a company or its partners – by not ticking a box to opt-out when you signed up, for example. If so, let them know you no longer want to receive sales and marketing calls.

You can register a complaint on the Telephone Preference Service website (www.tpsonline.org.uk). The TPS doesn't stop sales and marketing calls from overseas.

Rover spares

My Rover's electronic control unit (ECU) needs replacing, but my garage says it can't supply one. Where can I get Rover spares? DON FAIRLEY, COUNTY DURHAM

The Rover Group went into administration in 2005, but spares are still available through independent suppliers. Your garage should be able to get hold of an ECU, but if they insist they can't, you could supply one yourself and get your garage to fit it. Find an ECU specialist online (try www.ecuclinic.com) which will either repair your ECU or supply a suitable replacement on an exchange basis.

Most Rover spare parts are also available through www.xpart.com but, if it can't help, there are specialists for all parts of the car that should be able to.

In your credit cards report, you say that protection is provided under Section 75 of the Consumer Credit Act (CCA) for items costing between £100 and £30,000.

I recently bought an item online costing £15.90, which didn't arrive due to the retailer going into administration.

I decided to contact my card issuer, even though the CCA wouldn't cover this, and the sum was refunded.

It would be useful to let others know that it may be possible to recover sums less than £100. TIMOTHY COOK, COLEVILLE

Utility bills Dec 08, p80

Just like Tony Anderson, I complained to Eon when I received a letter informing me of a gas price rise almost seven weeks after it became effective.

I asked Eon to charge me the higher price only from the date I received notification, but it said that it had notified me within the required notice period, and Eon staff weren't even told of the changes until the day they were released, due to the sensitive nature of the information.

Too right, it was sensitive – around a 37% increase for me. With the help of Switch with Which?, I'm in the process of changing supplier, and anticipate a 10% reduction on my next bill. DEREK THOMAS, HULL

Providing the contract stated that it was non-refundable and nontransferable, you're not entitled to change the date free of charge.

These clauses can be in all contracts, though they're more likely to apply to discounted goods and services, as you often

pay less for little or no flexibility. Always double check key details when you're making a booking.

Send videos online

How can I send a 2GB video to friends and relatives? DON RAM BISHNANI, LONDON

That's a large video, and it's too big to send in an email, so try uploading it to a website and telling people where it is. This could take a long time, though.

On www.yousendit.com you can send files up to 2GB, and your intended recipient can access the file and keep it on their computer. The site offers a free 14-day trial.

Consider using YouTube (www.youtube.com) for shorter videos. It's free and lets you upload videos up to 1GB in size, or 10 minutes long. If you want only your friends and family to see it, use the privacy settings.



Credit reference agencies Nov 08, p14

Your report on credit reference agencies (CRAs) reinforced my experience of being rejected by a credit card company on spurious grounds – for not having a history of debt and not being on the electoral register.

Firms wanting easy credit checks should realise that they may be turning away good business by acting on the superficial methods currently used by the CRAs. I think the practice of making individuals responsible for contacting multiple CRAs, paying each of them £2, and then having to check the accuracy of information is a reversal of natural justice.

CRAs should have a duty to check every piece of information they put into their systems for accuracy with the affected individual. DR MARIANNE THORESEN, BRISTOL
