SAYS We're planning to laboratory test more table -top dishwashers in 2010 but, at the time of going to press, Bosch was due to discontinue our current Best Buy, the Bosch SKT5102 Classixx so we could not include this one in our report. It is due to release new models, however, and we'll be testing them as soon as they become available.

In your report on financial complaints, you state that if you are unhappy with a Financial Ombudsman Service ruling, you might consider making a legal claim. You also state that a solicitor must be used if the amount is over £5,000. I thought it was possible to pursue suitable claims via the Ministry of Justice's Money Claim Online service, without a solicitor, for up to £100,000 - is this true? KEVIN BUTLER. LONDON

There's nothing stopping you from pursuing a claim for more than small claims limits yourself, but the procedure can be complex and expensive if you lose. For these reasons, most people prefer to use a solicitor to give them the best chance of success rather than attempting to go it alone.

### Delivery

Our neighbours do a lot of online shopping and we often take parcels in for them.

We don't mind this, but as we have to sign for the parcels and know nothing about their contents, what would happen if these goods were then damaged or stolen? FRED GOLDIE, CHICHESTER

It would depend on whether your neighbour had given permission for you to receive the parcel – by leaving a note on their door asking to deliver to you if they weren't in. If they don't, the delivery company would be liable in the event of the goods being stolen. If they do, you would be liable.

### Isa transfer delay

I recently switched my Isa from NS&I to Halifax, but it was two and a half months before the funds were transferred. Is this a reasonable period? BARBARA GODFREY, GLOUCS

Transfers should take no longer than 30 days, according to HMRC guidelines – although this isn't enforceable. However, remember that your Isa is still earning interest as it's being transferred, so you haven't lost out financially.

### **Energy consumption**

Why didn't your breadmaker and microwave reviews include data on energy consumption? PAUL WINTER, FLEET

We don't include the data because differences in running costs are small. A microwave uses less energy than a conventional oven. The running costs of breadmakers are also similar – less efficient ones only cost one or two pence more per usage.
